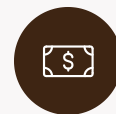

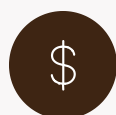

Step 5 — Power of Attorney (If Required)

If physical presence is required for registration:

- Limited Power of Attorney can be issued
- Attested through UAE-approved channels
- Used only for property-related formalities
- Fully revocable and transparent

This allows transactions to proceed **without travel**.

Step 6 — Property Registration & Ownership Confirmation

- Property registered with Dubai Land Department
- Title deed or Oqood issued in investor's name
- Digital copies shared immediately
- Physical documents couriered securely

You become the **legal owner**, even if you're overseas.

Typical Payment Structures for Dubai Property Investments

(Simple & Flexible Options for Global Investors)

Dubai real estate offers **flexible and investor-friendly payment plans**, making it possible to invest even without full upfront payment.

Below is how most investors typically proceed:



Sales & Purchase Agreement (SPA) and Golden Visa Eligibility

Once the investor completes the **initial required payments**, the property transaction reaches a legally secure stage.

Sales & Purchase Agreement (SPA)

- After paying **approximately 20% to the developer** (*may vary by project*)
- Plus **4% Dubai Land Department (DLD) registration fee**
- The **Sales & Purchase Agreement (SPA)** is issued by the developer
- The SPA confirms:
 - Property details
 - Buyer ownership rights
 - Payment schedule
 - Legal terms of purchase

This marks a **formal and legally recognized property purchase**.



Golden Visa Eligibility (Property-Based)

- After SPA issuance and DLD registration
- Investors may become **eligible to apply for UAE Golden Visa**
- Eligibility depends on:
 - Property value
 - Ownership structure
 - Compliance with UAE regulations
